STRATEGIC PLANNING COMMITTEE (Standing Committee)

Purpose: The purpose of the Strategic Planning Committee is to promote the stated purposes of business education in WBITE. Their charge is to use the Strategic Plan to review the progress of the Association and to make recommendations. Meetings shall be held at the annual conference prior to the Executive Board meeting. The committee will annually review the progress made in implementing the Strategic Plan goals and recommend actions as needed. Special committees such as Telecommunications, Keyboarding, etc., are often organized to focus on specific aspects of the strategic plan.

Composition: Membership shall consist of the immediate Past-President as Director. Additional members shall include two (2) additional WBITE past-presidents and two (2) STP presidents. The STP representatives are appointed on a staggered, rotation basis. An attempt will be made to include experienced and relatively new representatives from all STPs.
